Only children who are registered within three months of their birth will be considered. b. In the Reg. Form, child's name should be written as per the Birth Certificate issued by Municipal Corporation / Cantt. Board / Nagar Nigam / Gram Parishad. c. Birth certificates issued by Hospitals will not be accepted. d. 4. Copy of the Child's Aadhaar Card (if available).
5. **Original Fitness Certificate from a Registered Medical Practitioner (at least MBBS).**
6. Copy of the Vaccination Card of the child.
7. Copy of the Report Card of the other child if studying in St. Patrick's Academy, Meerut to get sibling points.
8. Copy of Caste Certificate, if belonging to SC/ST/OBC.
9. For Christian candidates, copy of the Baptismal Certificate should also to be attached.
10. Provisional TC or Bonafide Certificate from the present School / any proof of present School & class.
11. Proof of Residence Address: Aadhaar Card of parents / Electricity bill / BSNL telephone bill / Water Bill / Passport/ Voter I-card/ Domicile certificate of child or his/her parents (**ANY ONE**).
12. **AADHAAR CARD COPY OF THE FATHER and MOTHER (MANDATORY).**
